

## Traffic Analysis Report 2020-013 152nd Avenue SE and SE 41st Street



Thank you for contacting the City of Bellevue with your concerns about vehicle speeds on 152nd Avenue SE and SE 41st Street.

After conducting a field review and speed and volume studies, we have compiled the data and our recommendations into this Traffic Analysis Report.

Please review the summary of findings and our recommendations on the next pages.



You specifically were concerned about vehicle speeds on 152nd Avenue SE and SE 41st Street. To address this concern, you suggested speed bumps.

## Our findings include:

- Based on the recorded speed and volumes on the streets, we do not recommend moving forward with physical measures, such as speed bumps.
- Physical measures such as speed humps are limited to streets where the majority of motorists are exceeding the speed limit by 10 mph. Also, our guidelines for physical measures apply to streets with average daily volumes of at least 300 vehicles.
- We recommend you utilize our yard signs or radar dolly to help encourage motorists to respect the

# Summary of Findings

Below is a summary of the data we collected on 152nd Avenue SE and SE 41st Street from 10/4/2020 to 10/10/2020.



## **Road Characteristics**

152nd Avenue SE and SE 41st Street are residential streets approximately 35 ft wide. Parking is allowed on both sides of the streets.



## **Daily Traffic**


The mid-week daily average traffic on 152nd Avenue SE is 95 cars per day. Mid-week average includes data between Tuesday and Thursday for both directions of travel.

The mid-week daily average traffic on SE 41st Street is 89 cars per day.



#### **Residential Street**

152nd Avenue SE and SE 41st Street are residential streets in Eastgate with a speed limit of 25 mph.






## Speed Study

When measuring vehicle speed, we use a metric called the 85th percentile speed. This speed, shown to the right, represents the speed at which 85% of all vehicles recorded are traveling at or below during our speed study on 152nd Avenue SE.

The 85th percentile speeds on SE 41st Street are 22.4 mph in the eastbound direction and 22.8 mph in the westbound direction.





## **Collision History**

A three-year collision study was conducted on 152nd Avenue SE between SE 39th Street and SE 41st Street and on SE 41st Street between 151st Avenue SE and 152nd Avenue SE.

FINDINGS: There were no reported collisions.

## Summary of Recommendations

Below are our recommendations for 152nd Avenue SE and SE 41st Street based on the field reviews, data collection, and analysis. More detail on these recommendations are outlined in the Residential Traffic Guidebook (BellevueWA. gov/ResidentialTrafficGuidebook). By educating the community and encouraging safe driving, we can begin to change driver behavior and reduce vehicle speeds.

## **Traffic Safety Yard Signs**



This program involves lending communities portable signs that encourage motorists to respect the neighborhood, drive responsibly, and drive 25 mph.

## Radar Dolly



You can borrow and place a radar dolly on your street for up to two weeks. This unit gives motorists feedback on the speed at which they are driving on a digital reader board, encouraging them to obey the speed limit. Should you like to borrow the radar dolly, please request it by calling 425-452-6457 or sign up on <u>BellevueWA.gov/RadarDolly</u>. Once we receive a request, city staff will contact you to make arrangements for both the drop-off and pick-up of the radar dolly at your home.
