

Construction Alert

112th Avenue NE Corridor Improvements



May 2021

The City of Bellevue Transportation Department is planning the following safety improvements along 112th Avenue NE, between NE 12th Street and NE 24th Street:



Replace sidewalk panels on both sides of the street where street tree roots have caused, or could cause, the sidewalk to become uneven.



Install a flashing beacon, mid-block crossing and median island near Hidden Valley Sports Park to enhance pedestrian safety.



Replace non-compliant curb ramps to meet federal accessibility standards.




Install a new traffic signal at 112th Avenue NE and NE 24th Street to improve traffic flow.



Repave the roadway to improve the pavement and extend its life.



Add underground conduits to support a future street lighting upgrade project when funding becomes available.



Schedule and impacts

Construction is anticipated May through the end of 2021. Construction schedules are subject to change and often do.

- **Approved work hours:**
Monday-Friday, 7 a.m. to 6 p.m.
- **Traffic impacts:** Intermittent lane closures and delays; two-way traffic will be maintained.

- **Sidewalk access:** Closures are needed for repair work; however, access will be maintained on the opposite side.
- **Tree removal/replanting:** Due to hazardous conditions, approximately 60 trees along the sidewalk within the project area will be removed to avoid future problems with sidewalk heaving. As mitigation, 100 new trees will be planted in a designated area at Hidden Valley Sports Park.

Thank you for your patience during construction and for exercising caution near the work zone. Please follow flaggers' instructions and traffic control signs, including detour signs.

Funding

This project is primarily funded by the Neighborhood Safety, Connectivity and Congestion Levy, with support from other capital investment funding sources. Estimated construction cost is \$2.9 million.


