

# CONSTRUCTION ALERT

## Mountains to Sound Greenway Trail: 132nd Avenue SE to 142nd Place SE

Construction is anticipated to begin in February to add a new segment of the Mountains to Sound Greenway Trail, from 132nd Avenue SE to 142nd Place SE. New construction will include:

- The continuation of a 12-foot-wide paved pedestrian and bicycle path on the north side of SE 36th Street.
- New retaining walls, lighting, landscaping, pavement restoration, and urban design features.
- Improvements to the traffic signals at SE 36th Street and 136th Place SE and 142nd Place SE.

### What to expect

Construction is expected to be completed by the end of 2021. Expect weekday, weekend and night work. Construction schedules are subject to change and often do.

### Funding

Construction funding comes from the city's Capital Investment Program and Neighborhood Safety, Connectivity and Congestion Levy, and grants from Sound Transit and the Puget Sound Regional Council. The estimated construction cost is \$9.3 million.
