WELCOME AND ROLL CALL: The meeting was called to order by Anne

Rittenhouse. Anne introduced the newest member of BNOA, Joyce Hansbearry. Joyce thanked the group for allowing her to be part of the Network and spoke of her background in older

adult housing.

PUBLIC COMMENTS: Mr. Yamada indicated he was visiting to hear what the

BNOA does. Mr. Yamada indicated that he works in the tech industry looking for free tech services

for older adults.

APPROVAL OF MINUTES: June 2024 minutes were approved.

Presentation: With the assistance of Bellevue IT Dept, Kirill Mitkovetskiy, the BNOA met under the usual ZOOM meeting and receiving direction on how to attend a TEAMS meeting without downloading the TEAMS application, went out of ZOOM and rejoined using a TEAM'S meeting invitation. Kirill worked with each member who had issues with their system to regain sound, picture, backgrounds, meeting views, chat function, hand raising and lower functions. The process took a full hour to get everyone up and running but ended with a successful meeting application transfer. The BNOA requested that at meetings Dan use the "pin the speaker' feature as was easier to see who was speaking for the group. All future meetings will use the TEAMS application. The various meetings for BNOA will each have the same monthly invitation and id number to enter the meetings.

Human Services Report – Christy Stangland

Christy reports that the Human Services funding recommendations to council are near completed. Shelters will be funded and 70% of those culturally underrepresented in the City of Bellevue will get funding. Future additional funding will likely be recommended and provided through the City Council. Christy reported that during COVID, an extra 10 million dollars were made available that is no longer, but the need is the same.
