156th Avenue NE: Main Street to NE 6th Street Pedestrian Improvements

Project Description: This project aims to improve pedestrian safety and connectivity on the 156th Avenue NE corridor. The scope of the project includes:

- Enhancing existing midblock crosswalks at NE 4th Street and NE 6th Street, including installations of rectangular rapid flashing beacons (RRFB), new crosswalk markings, and Americans with Disability Act (ADA) compliant curb ramps.
- Installing a new midblock crosswalk at NE 1st Street, including a RRFB system, new crosswalk markings, and ADA compliant curb ramps.

• Installing a new sidewalk on the east side of 156th Avenue NE from NE 1st Place to NE 1st Street, connecting the new crosswalk to sidewalk.
