Resolution No. 500

A RESOLUTION of the East Bellevue Community Council approving City Council Ordinance No. 5802 relating to the Comprehensive Plan of the City of Bellevue, as required and adopted pursuant to the Growth Management Act of 1990, as amended (Chapter 36.70A RCW); adopting 2007 amendments to the Comprehensive Plan amending the Utilities General Element to: amend the text of the Goals section; amend the text of the Electrical Service and Natural Gas subsections of the Non City-Managed Utilities section; add new policies to the Non City-Managed Utilities – Additional Electrical Facilities section; delete Figure UT.5 Electric Transmission Facilities and add new Figure UT.5 – Existing Electrical Facilities and new Figure UT.5a – New or Expanded Electrical Facilities; and amend Figure UT.7 – PSE Natural Gas Mains.

WHEREAS, on the 25th day of February, 2008, the City Council of the City of Bellevue, Washington passed Ordinance No. 5802 relating to the Comprehensive Plan of the City of Bellevue, as required and adopted pursuant to the Growth Management Act of 1990, as amended (Chapter 36.70A RCW); adopting 2007 amendments to the Comprehensive Plan amending the Utilities General Element to: amend the text of the Goals section; amend the text of the Electrical Service and Natural Gas subsections of the Non City-Managed Utilities section; add new policies to the Non City-Managed Utilities – Additional Electrical Facilities section; delete Figure UT.5 Electric Transmission Facilities and add new Figure UT.5 – Existing Electrical Facilities and new Figure UT.5a – New or Expanded Electrical Facilities; and amend Figure UT.7 – PSE Natural Gas Mains; and,

WHEREAS, the subject matter of said Ordinance falls within the jurisdiction of the East Bellevue Community Council pursuant to RCW 35.14.040; and

WHEREAS, following the public hearing held before the East Bellevue Community Council on April 1, 2008, the Community Council voted to approve Bellevue Ordinance No. 5802;

NOW, THEREFORE, BE IT RESOLVED by the Community Council of the East Bellevue Community Municipal Corporation of the City of Bellevue:

Section 1: Ordinance No. 5802 of the Bellevue City Council is hereby approved.


