

Pilot turn restrictions in Woodridge effective in discouraging commuter traffic; pilot to continue through June 2019.

Project background


A six-month pilot project began in July 2018 to discourage evening traffic from cutting through the Woodridge neighborhood. Time-based (Monday-Friday, 4-7 p.m.) turn restrictions were installed at 128th Ave./ SE/SE 32nd St. and 128th Ave. SE/SE 30th St. to discourage commuters from using Woodridge streets to access Richards Road. These restrictions were selected after holding multiple community meetings and consulting with a volunteer group of Woodridge residents. All project documentation can be found on:

Key findings to date

- Reduced queuing on southbound 128th Ave. SE improving neighborhood flow and access
- Traffic volumes are down 37% on 128th Ave. SE just north of SE 32nd St.
 - Left turning vehicles from 128th Ave. SE to SE 32nd St. (back to Richards Road) have decreased by 80%
- Routing apps (e.g. Waze, Google Maps) reflect the changes and don't route drivers through the turn restrictions
- Bellevue Police officers have issued more than 200 citations and are on site at least once per week
- There is minimal U-turning occurring from southbound I28th Ave. SE to westbound SE 32nd St. to avoid the restrictions
- A total of 73 comments were received, primarily from residents who did not attend earlier engagement opportunities (comments can be found on the project website)

Next steps

While the initial results of the pilot are promising, we want to continue its evaluation through June 2019. Based on additional informed analysis, a determination will be made in June 2019 on the future of the turn restrictions.
