The primary study area includes approximately 10 acres of cityowned property, including the existing Meydenbauer Beach Park and the Bellevue Marina, in addition to privately-owned property. A larger "secondary study area" arcing around the perimeter of the primary study area has also been identified.

**Description:** This Final EIS is being issued by the City of Bellevue, and has been prepared based on agency and public comments received on the Draft EIS during the formal public comment period. It also reflects a Preferred Alternative that was developed by the Meydenbauer Bay Park and Land Use Plan Steering Committee, and evaluates potential environmental impacts associated with that alternative. Like the alternatives evaluated in the Draft EIS, the Preferred Alternative addresses not only future park development, but potential land use changes within the primary study area.
